Three kids die after Measles, Rubella shots

As part of routine drive, in Belgavi district, 21 children received MR and other vaccines after which four took ill

THREE children have died after receiving Measles and Rubella (MR) vaccine jabs in Belagavi district. About 21 children were given MR and other vaccine shots in the Salahalli Primary Health Centre limits in Ramdurg taluk on January 12. Among them, the health of the four children worsened, subsequently three children died, while one child is still fighting for survival in the hospital.

The deceased have been identified as Pavitra Hulagur (13 months) and Madhu Umesh Karagundi (14 months), both residents of Bochabal village, Ramdurg taluk and Chetan (15 months), a resident of Mallapur village of Ramdurg taluk.

According to the health officials, the routine monthly vaccination session was conducted in all the PHC limits in Ramdurg on January 11 and 12. About 21 children were given routine vaccine shots at anganwadi centres in Bochbal village in the Salahalli Primary health centre limits on January 12. The four children among those who were given Measles and Rubella vaccines.

First dose of below one-year was given to two children while the MR dose of above one year was given to two children. The Penta and Polio vaccine was given to 17 other children at the vaccination centre. After two hours, the four children who

were given MR dose, started feeling uneasy, and had diarrhoea symptoms. They were taken to Ramdurg taluk hospital. However, one child died in the taluk hospital while one died after returning home. As the condition of two other children worsened, they were referred to BIMS Hospital, Belagavi on the same day. However, one child died while giving treatment in the ICU on Saturday night and another child is fighting for survival in the hospital.

Bhimashi Hadimani, Grama Panchayat member of Bochabal said, "The health department officials were not cautious while conducting the vaccination drive. There is some negligence on the part of

the health staff." District Health Officer Dr SV Munyal said, "The vaccination drive was arranged separately at the centre at Bochbal. After discussing with the paediatric specialist, we came to know that children might have become victims due to reaction to the vaccine. But, I had never seen such a kind of a reaction before. We found new symptoms like diarrhoea, loose motion in children after MR

vaccination."

"We have conducted the postmortem of a baby and conducted all legal processes. On receiving information on January 12, we formed a District level Adverse Reaction Following Immunisation (ARFI) Committee and discussed this incident in the Committee. We have collected the urine, faecal, and blood samples, and sent them to state level and national level laboratories for testing. I have also directed the Reproductive and Child Health Officer (RCHO) to submit a report by evaluating the vaccination process, protocol, vaccination storage and distribution system in Ramdurg and further measures will be taken once we get reports," he said.

Secunderabad Club gutted in pre-dawn fire

A ravaging pre-dawn fire devoured a major portion of the 144-year old iconic Secunderabad Club here on Sunday.

The fire reduced sixty percent of the main building of the club to ashes, which also houses the offices of the Club President and other functionaries.

As many as seven fire tenders from different parts of the city rushed to the club going up in flames in Secunderabad abutting the Rajiv Rahadari highway and brought the fire under control after battling with leaping flames for

Though the fire was huge, it did not spread out of the building and also to the Club's fuel station located a few hundred metres from the affected part. If the fire had spread to the fuel station, the damage would have been extensive, officials said.

As a major portion of the building is made of wood, fire spread rapidly resulting in a huge property loss. The bar located in the ground floor of the building added fuel to the fire. As the fire occurred in the early hours and there was no movement of people, a major mishap has been averted, said fire officials. Area spread around 25,000 SQ FT was gutted in the incident, they said.

After serving members on Saturday, the club closed at 11 p.m., after which the clearing

up work continued for sometime. Around 3am on Sunday, there were only security personnel and some kitchen staff working. It was the security personnel who noticed fire first and immediately alerted the fire department and police.

The staff who first saw the fire told officials that it spread from top portion to the lower parts of the building. Police and fire teams rushed to the spot and began battling with the rogue flames. Before the fire tenders arrived, the club

staff tried to contain the fire using the fire extinguishers, but to of no avial, as the fire was huge, which had by then engulfed the build-

ing within a few minutes.

Chandana Deepti, DCP North Zone, Hyderabad city police told Express that the exact cause of fire is yet to be established, as the building was badly damaged and is now in an unsafe condition to enter the area. Only the skeletal structure is left after the fire came under control which can come down anytime. "We are investigating various angles. Samples from the spot would also be sent for forensic analysis. The property loss is also yet to be ascertained." Police are also verifying if the Club has a fire safety mechanism and whether fire safety drills are conducted at the place on a regular basis.

Along with Police, fire and electricity departments are also probing the incident.

HEMA COMMISSION REPORT SHOULD BE MADE PUBLIC: WCC

FIVE members of the Women In Cinema Collective (WCC) on Sunday met Women's Commisdemanding the disclosure of Hema Commission report that studied the troubles being faced by the women in the film industry.

The commission was constituted based on the WCC's request before Chief Minister Pinarayi Vijayan against the backdrop of the actress abduction incident in 2017. P Sathidevi, however, told reporters here that there is no need to publish the Hema Commission report. that was submitted to the government in 2018. According to the government, the report was not to be made public in order to respect the privacy of the statements given by the women in

film industry. The WCC members - director Anjali Menon, singer Sayanora, script writer Deedi Damo-

daran, actor Parvathy Thiruvaoth and Padmapriya - had to approach the women's commission again as they alleged that the government has not considered their recommendations, sion chairperson P Sathidevi despite the commission having submitted its report four years ago.

She said that she would inform the government about the issues raised by the WCC regarding the problems of

women in the industry. It was up to the film production companies to ensure safety of women and the government should take further action on the Hema committee report, she said.

Actress Parvathy Thiruvoth has said she has detailed her personal problems before the Hema committee. "Those who post on social media in support of the actress who was assaulted should clarify whether there is an internal complaint committee in their own production company. That is how we should stand with women," said Parvathy.
