

# WORLD BIDS FINAL GOODBYE TO QUEEN ELIZABETH II

After poignant state funeral, the late monarch's body lowered into royal vault at St George's Chapel

## LONDON

QUEEN Elizabeth II's coffin was on Monday lowered into the Royal Vault at St George's Chapel in Windsor Castle, bringing to an end public mourning for Britain's longest-reigning monarch.

The “second Elizabethan age” was symbolically brought to a close when the highest-ranking official in the royal household, Lord Chamberlain Andrew Parker, broke his wand of office and the Imperial State Crown, orb and sceptre were placed on the high altar.

The Queen's funeral service at Westminster Abbey ebbed between moments of triumph and peace, lament and emotion — and awesome majesty.

Inside the imposing Gothic church, royalty and government leaders said farewell to a

monarch whose longevity and omnipresence made her — in the words of French President Emmanuel Macron — “The Queen”.

It was at the abbey in 1953 that she was crowned. It was there that she married Prince

Westminster Abbey's tenor bell tolled every minute for 96 minutes, signifying the age at which Britain's longest-reigning sovereign died on September 8.

Each strike added to the anticipation, while the organ music, played in minor keys, grew louder and deeper as the bearer party approached.

As the coffin arrived at the Great West Door, the 2,000 congregants stood in a wave spreading towards the altar.

Eight Grenadier Guardsmen in scarlet jackets, their bearskin hats removed, carried the coffin over the memorial stone for Winston Churchill, the first of Queen Elizabeth II's 15 prime ministers.

The late monarch's eldest son, King Charles III, led the royal family walking slowly behind the coffin. *Agencies*

# RUSSIAN MISSILE LANDS CLOSE TO NUCLEAR PLANT IN UKRAINE'S EAST

**KYIV**

A Russian missile struck close to a nuclear power plant in southern Ukraine without damaging the three reactors but hit other industrial equipment in what Ukrainian authorities denounced Monday as an act of “nuclear terrorism.”

The strike followed warnings from Russian President Vladimir Putin of possible stepped-up attacks on Ukrainian infrastructure after his forces suffered humiliating bat-

lefield setbacks. It also renewed fears of a possible radioactive disaster in the nearly 7-month-long war. The missile struck within 300 meters of reactors at the Pivdennoukraiinsk plant, also known as the South Ukraine Nuclear Power Plant, blasting a crater 2 meters deep and 4 meters across, according to Ukrainian nuclear operator Energoatom.



Black-and-white CCTV footage released by Ukraine's Ministry of De-

fense showed two large fireballs erupting one after the other in the dark, followed by incandescent showers of sparks. A time stamp on the video read 19 minutes after midnight.

The ministry and Energoatom both called the strike "nuclear terrorism." The Russian Defense Ministry had no immediate comment. The United Nations' nuclear watchdog, the International Atomic Energy Agency, did not immediately respond to a request for comment.

## Writer Meena Kandasamy wins German literary award

Feminist writer Meena Kandasamy is the winner of this year's Hermann Kesten Prize by the German PEN Center. German broadcaster DW News reported on Monday, "Honestly, I am not sure how to process it," Kandasamy told DW News. "Previous recipients include Günter Grass and Harold Pinter, and the weight of what this prize means is actually still sinking in," she said. Kandasamy noted that she sees the award "not only as an affirmation of what I have done, but of the historical responsibility that we all have as progressive writers and artists in India today." Vice-president of the German PEN Center Cornelia Zetzschke called the 37-year-old born in Chennai, "a fearless fighter for democracy and human rights, for the free word and against the suppression of landless people, minorities and Dalits in India".
